#### New Hazardous Waste Rules Effective August 3, 2020

Agency: Environment, Great Lakes, and Energy

On July 27, 2020, amendments to the rules promulgated under Part 111, Hazardous Waste Management, of Michigan's Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Part 111), were filed with the Michigan Department of State, Office of the Great Seal. The rules become effective on August 3, 2020.

#### **Summary of Revisions**

These revisions address the following subject areas:

- Generator improvements rule (GIR) (81 Federal Register (FR) 85732, November 28, 2016)
- Exports/imports (81 FR 85696, November 28, 2016 and 82 FR 60894, December 26, 2017)
- E-manifesting (83 FR 420, January 3, 2018)
- Definition of solid waste 2018 court vacatur (83 Federal Register (FR) 24664, May 30, 2018)
- Designation of aerosol cans as universal waste (84 FR 67202, December 9, 2019)
- · Elimination of 52 state-only hazardous waste listings

The GIR significantly restructured the generator rules to make it easier to determine the requirements that apply to each type of generator and include provisions for episodic events and large quantity generator consolidation of certain wastes.

# **Covid-19 Inspection Protocols**

- Un-announced inspections are now announced, with the exception of complaint investigations
- Inspectors request records to be sent by the generator to the inspector via e-mail
- EGLE management is requiring inspectors to send compliance communication within 10 days of the inspection



### Example of Requested LQG Records

- A map of the facility indicating hazardous waste accumulation areas, satellite areas, and any processes that generate hazardous waste
- Waste characterization profiles for the following waste streams: xx, xx, and xx
- Uniform hazardous waste manifests from xx through xx
- Biennial Reports for xx and xx



### Example of Requested LQG Records

- Land disposal restriction forms for the following generated hazardous waste: xx, xx, and xx
- Inspection records for 90-day accumulation area(s) from xx through xx.
- Employee training records, including an employee training plan and the resume of the individual performing the training
- Emergency Contingency Plan

#### HAZARDOUS WASTE AND LIQUID INDUSTRIAL BY-PRODUCTS CHARACTERIZATION AND GENERATOR STATUS. (APRIL 2, 2020)

In this webinar, attendees will learn the basic steps for determining if a waste is a hazardous waste, liquid industrial by-product, or non-hazardous solid waste, and how to calculate your site's hazardous waste generator status. These concepts are vital to understanding how to properly manage and dispose of waste. It's vital because the hazardous waste regulations require each business at each site to evaluate the character and composition of their waste and determine the total weight of all hazardous waste generated each month. Until this information is known, you don't know the legal disposal options for the waste.
