- Causes inflammation



Part 19 Air Pollution Control Rules

Marginal Offset Requirements

1.1 to 1 ratio

NOx or VOC

Real reductions

Same nonattainment area

Baseline year to permit issuance



Baseline Year

• Act 451 5505(2):

"The start date for the emissions offsets eligible to be applied to a permit to install shall be the date established by federal rule or, if a date is not established by federal rule, January 1 of the year after the emissions baseline year used for the purpose of preparing the relevant state implementation plan."

 DC Circuit Court: baseline year must have a statutory basis

South Coast Air Quality Management District v. EPA, No. 15-1115 (D.C. Cir. 2018)

- VOC RACT
 - Based on Control Technique
 Guidelines
 - MI considering as part of 2015 ozone attainment plan
- NOx RACT
 - CSAPR Update
 - -CAIR



Additional Moderate Requirements

- Additional 15% VOC reductions
- Basic Vehicle Inspection and Maintenance Program
- Stage II Gasoline Vapor Recovery



What Happens If We Don't Submit a SIP in time?

- Federal Implementation Plan (FIP)
- Sanctions
 - NSR offset ratio of at least 2 to 1
 - Highway funding sanctions
